
A Toolkit for Centering Racial Equity Within Data Integration

2020 Census Outreach – Final Stretch

Right now, thousands of census takers across the United States are knocking on doors and calling households that have not yet filled out their 2020 Census questionnaire. We are in the final outreach stage of this massive effort to count everyone who still has not responded on their own. Dedicated census staff equipped with personal protective equipment (PPE), are working 12 hours a day, seven days a week, to make sure we count all those who remain uncoun­ted. As of September 1, 2020, over 84.1 percent of the nation’s housing units have been counted.

First-of-its-Kind Partnership Aims to Redesign Child Welfare Into Child- and Family Well-Being Systems

The U.S. Children’s Bureau, Casey Family Programs, the Annie E. Casey Foundation and Prevent Child Abuse America are partnering to launch a national effort to prove it is possible to fundamentally rethink child welfare by creating the conditions for strong, thriving families where children are free from harm.

This first-of-its-kind effort — Thriving Families, Safer Children: A National Commitment to Well-Being — will work across the public, private and philanthropic sectors to assist jurisdictions in developing more just and equitable systems that benefit all children and families and break harmful intergenerational cycles of trauma and poverty.

2020 Census: Information for CoCs

Continuums of Care and providers were contacted by their [Area Census Office](#) (ACOs) to confirm service-based enumeration processes and locations no later than September 11.

- [Service-Based Enumeration](#) (shelters, soup kitchens, etc.) counts will take place between September 22-24
- Targeted Non-Sheltered Outdoor Locations (unsheltered) counts will take place the night of September 23 into the morning of September 24
 - Providers are encouraged to inform their clients of the Census dates, and that enumerators will wear bright orange vests during the unsheltered count

ACOs will be adding service-based enumeration locations up until September 21, so be sure to be in contact with your ACO to establish your site as an enumeration location if you have not been contacted.

The Office of Head Start recently issued its much-anticipated revisions to the Designation Renewal System (DRS) rule, which include changes to three key areas affecting recompetition: CLASS reviews, monitoring deficiencies, and audit findings. In this webinar, we will outline the specific changes in the new rule, explore what they mean for your agency, and discuss what your agency should do in response to them.

We will also discuss the potential impacts on recompetition from the Office of Management and Budget's recent Uniform Guidance updates as well as from the new audit compliance supplement.
